ORDER

NCTE

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND, WHEREAS, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned against their name.
- AND, WHEREAS, the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./B.P.Ed./M.Ed. as mentioned in para 5 below against their name, which may require additional facilities.
- AND, WHEREAS, it has been decided to permit the institution to have the desired number of units subject to fulfilling the following conditions:-
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The applicant Institution for additional unit will be required to submit the required documents, such (ii) as, land documents, Non Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided the additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting Team at the time of inspection.
 - The Regional Committee shall arrange for verification of documents, inspection of the premises and (iii) check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of (iv) the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Section 17/complaint cases etc. as decided by the Northern Regional Committee.
- Now, therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to the following institutions for conducting the under-mentioned programme/intake of two years duration from the academic session 2015-2016 subject to fulfillment of the conditions before 31.10.2015 mentioned in para 4 above:-

खप नगर नियोजक, अलवर क्षेत्र अलवर की अन अंकित शर्तानुसार तहसीलंदार अलवर ने अपने 429 दि. 17.08.16 द्वारा अवगत कराया है आव्खवनंव 438 रकेबा 0.51 हैं में से 0.1529 हैक्टेयर भूमि रास्ते हेतु निःशुल्क समर्पित की जा चुकी है। जिसका नामान्कतरण 738/11.08.16 स्वीकृत हो चुकां है।

8. उपर्युक्त अकृषि प्रयोजन के लिए संपरिवर्तन आदेश निम्नलिखित शर्तों के अधीन होगा :-

(1) उपर्युक्त अकृषि प्रयोजन के लिए संपरिवर्तन भूमि का उपयोग विहित अधिकारी की पूर्व अनुजा। प्राप्त किए बिना अन्य किसी प्रयोजन हेतू नहीं किया जावेगा।

(2) अलवर-बहरोड सडक से ग्राम बाला डहरा को जाने वाली ग्रामीण सडक की चौडाई सार्वजनिक निर्माण विभाग के अनुसार 100 फुट रखी जावेगी।

(3) प्रस्तावित भूमि पहाड की तलहटी में स्थित है, अतः जल प्रवाह / सुरक्षा आदि के मध्य नजर ही विचार किया जाकर तथ्यों के संबंध में आवश्यक समस्त पैरामीटर का ध्यान प्रार्थी द्वारा रखा जावेगा।

(4) यदि आवेदक इस आदेश के जारी होने की दिनांक से दो वर्ष की कालावधि के भीतर संपरिवर्तन प्रयोजन के लिए भूमि का उपयोग करने में विफल रहता है तो अनुज्ञा प्रत्याहित कर ली जावेगी और आवेदक द्वारा जमा कराया गया प्रीमियम धन समवृहत हो जावेगा।

(5) रूपान्तरित भूमी का उपयोग कॉलम सं० 4 में अंकित प्रयोजन (शिक्षण संस्थान) के लिये ही किया जावेगा।

(6) प्रार्थी की भूमि सड़क विस्तार हेतु आवेदक द्वारा कॉलम सं० 7 के अनुसार निःशुल्क समर्पित की जा चुकी है। निःशुल्क समर्पित की गई भूमि पर किसी प्रकार का कोई निर्माण कार्य, जिसमें बाउण्ड्री वॉल भी शामिल है, नहीं किया जायेगा।

(7) प्रार्थी द्वारा भवन विनियम, 2010 के प्रावधानुसार सामने का सैट-बैक 15 मीटर तथा शेष तीनों तरफ 9-9-9 मीटर तथा अधिकतम् आच्छादित क्षेत्र 35 प्रतिशत एवं एफ०ए०आर० 1.0 रहेगी।

(8) प्रार्थी द्वारा शिक्षण से संबंधित तथा आगुन्तकों के वाहनों की पार्किंग, भवन विनिमय-2010 के प्रावधानुसार एवं प्रस्तावित भूमि के अन्दर ही किया जाना सुनिश्चित किया जावेगा।

(9) प्रार्थी द्वारा प्रस्तावित स्थल हेतु केवल एक प्रवेश द्वार ही रखा जावेगा।

(10) प्रार्थी द्वारा भवन विनियम, 2010 के प्रावधानुसार शारीरिक रूप से अशक्त व्यक्तियों के लिए प्रवेश / निकास द्वारों को जाने का गलियारा, सीढी मार्ग, शौचालय, पेयजल इत्यादि का निर्माण सुनिश्चित किया जावेगा।

(11) प्रार्थी द्वारा भवन विनियम, 2010 के प्रावधानुसार जल-मल संबंधी विभिन्न व्यवस्थायें राष्ट्रीय

भवन संहिता के अनुरूप होगीं, जो संस्था द्वारा स्वयं अपने स्तर पर करनी होगी।

(12) भवन विनिमय, 2010 के प्रावधानानुसार पानी गर्म करने हेतु सौर उर्जा संयंत्र लगाना आवश्यक होगा।

(13) प्रार्थी द्वारा भवन विनियम 2010 के प्रावधानानुसार भूगर्भ का जल स्तर बढ़ाने हेतु वर्षा के पानी को एकत्रित करने के लिए समुचित क्षमता का भूमिगत एक या एक से अधिक टैंक बनाया जावेगा प्रमाणित छाया प्रात के रिसाव हेतु बोरवैलनुमा अथवा सोकपिट जैसी अन्य व्यवस्था की जावेगी।

- 6. This revised order will be treated as cancelled in respect of those cases where recognition of the institution has been withdrawn by NRC, NCTE.
- 7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display the following mandatory disclosure:-
 - (a) Sanctioned programme(s) along with annual intake in the institution.
 - (b) Names of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Names of faculty members who left or joined during the last quarter.
 - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.

(g) Facilities added during the last quarter.

(h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.

(i) The affidavit with enclosures submitted along with application.

- (j) The institution shall be free to post and additional information, if it so desires.
- 10. Any false or incomplete information on the website of the institution shall render the institution liable for withdrawal of recognition.
- 11. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there-under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
